

We cleaned up Freddy and put him in the Concours on Sunday and took 4th in Closed Cars. After we left Aspen on the return trip we didn't see a single Alfa!

Highlights-We were cruising through Yosemite when we got behind a Capri and a Datsun 510 going 10-15 mph up a very steep, windy, grade. Now I know why Capri leads all cars but one! It gets in front on a curvy road where you can't pass and it can't

pass the VW because it's in front going slower. We got some hot gas and the fuel pressure light started to blink at me-instant heart failure! The pump is going out miles from an Alfa dealer! We waited at a rest stop pondering our problem. We started up with no more problems until Grand Junction, Colorado when the problem cropped up again. We found out from sources that the fuel gets hot circulating through the system and the pump loses it's power to pull the expanded gas from the tank. So, when you put excessive demands on the pump the light blinks. Getting the pump and gas cooled off solves the problem.

We cruised 70-80 mph and a bit faster on straight stretches coming back. We averaged 27.2 mpg and no fuel shortages. How many American cars can clain that! I heard that some AROSC cars cruised over 100 mph and were getting 20 mpg--not bad!

Stares--my gosh!! It was as if we were invaders from out of state. Weirdo's with strange machines from parts unknown. Like my earlier article "what's an Alfa Romero?" People would see us coming and watch a blue streak go by with tailights trailing. Maybe that Winnebago was trying to see what kind of cars they were driving. Ask Samson about that!


P.S. You missed one helluva good time! Detroit next year. Let's show them what real cars are.
