

# RACING AROUND

AROSC Time Trial Program for 1974 by Allan Gott.

In 1973, AROSC continued its successful time trial program which was started in 1972. Four events were held; Pomona, Orange County International Raceway, Riverside International Raceway, and Willow Springs International Raceway. A total of 103 entrants participated in this program and several thousand high speed miles were driven. Safety is certainly the most important aspect in an event of this type, and AROSC obviously scored high in this regard in 1973.

Plans for 1974 are still being discussed by your Board of Directors and hopefully will be finalized in time for publication in the February Alfacionada. We are hoping to stage as many as four time trial events with a different Event Chairman for each event at the following tracks: Pomona, Riverside, Ontario, and Willow. In addition to trophies for each event, we will continue the scoring system which was used in 1973 and again present an overall championship trophy for the four-event season.

In the interest of <u>safety</u>, scoring, car classification, and many other topics, I urge you to read the new 1974 AROSC Competition Code very carefully. As a paid up 1974 AROSC member, you will receive a copy of this code in late January or early February. Several changes have

in the Club's high speed driving events which were held at Cotati and Vacaville Raceways in Northern California. In 1972, I moved back to Southern California and immediately joined AROSC. During 1973, I participated in all four Alfa Time Trials and also obtained my Solo I license in August. I hope he plans to enter the AROSC Time Trials in 1974. He has been a hard worker, having served on the Board for 7 years.

#### Neil Meyer - Treasurer

After Willow Springs, you will probably remember him as the "White Hulk." His 1600 GTV showed its tail to many cars with more preparation during 1973. If he keeps this up, we may make him run in the modified class! Neil is a "Cornhusker" who came to California in 1944.

He lives in Long Beach and practices as a Speech Pathologist in Los Angeles. He has owned one Alfa, as described above. Neil slalomed in 1973 doing very well and also competed in the Club Time Trials, finishing fifth over all in both categories for the year. He plans to focus his competitive interests on the AROSC Time Trials this year assuming he can replace or repair his "White Hulk." This is his second year on the Board as Treasurer.

#### Dick Barlow - Secretary

2 - Nuts Part No. 105.12.28.100.01

1 - Bolt Standard 2100.00631

1 - Washer Standard 2140-16677 Time allowed for the complete operation: One-half hour.


### **JANUARY MEETING**
