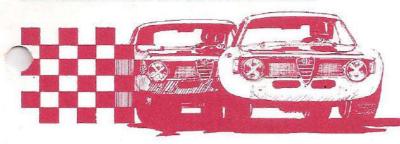

ALFAsud-aTI

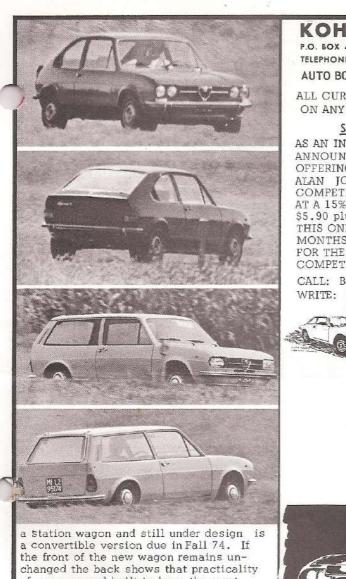
In France like in Italy and the rest of Europe, the Alfasud is liked by many and the constructor cannot produce enough for the demand. Many of the people that do appreciate this car wish that it had more power and have a better finishing touch. On these two wishes it leaves Alfa with progress to accomplish. To reply to these demands well justified, Alfa Romeo, has come out with a TI version, maintaining the 1183 cm³ engine but being equipped with a big two barrel carburator and a five speed transmission. The pick up is better and top speed is 10 km/h greater: making a speed of 163 km/h instead of 153 km/h.

The coachwork of the TI will be recognized by only 2 doors. But the chassis is still the standard 4 door one. Inside a more luxurious Alfa touch is added as well as a tachometer, headrests on the seats. The difference in price from a standard Alfasud and a TI is about 400 dollars. The price in France for an Alfasud normal, is 3100 dollars.

Built in the new factory in Naples, the Alfasud is fitted to a style that no other Alfas has ever had. The daily fabrication pace for Alfasuds is already more than 500 and is sure to make progress. At the same time other versions will also multiply After the Alfasud TI, Alfa comes out with

a Station wagon and still under design is a convertible version due in Fall 74. If the front of the new wagon remains unchanged the back shows that practicality of a wagon and built to have the most space possible in the car. In building this style Alfa plans to expand its sales even if it means creating a non sporty Alfa. This model is not yet available for exportation in Europe, the TI will be available in Spring of 74.

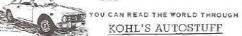

A LETTER TO THE EDITOR

A Letter addressed to all members of A.R.C.S.C. who are planning to run in the time trial program. It is my feeling that our code as it is, is the best and most concise that I have seen. But there is one area that I feel is to complex to function well. That area is the classification of cars. Below you will find my proposed changes. These changes work within the code as it is.

4.5 G. Scatter shields are recommended in all Mod. Street prepared cars.

4.8 Classes:

- A. SCCA cars over 1600cc All Formula and Sports Racing cars Improved and Mod. TZ's All class C to Mod. Street specs.
- B. SUCA cars under 1600cc Stock TZ's All class C to Improved Street specs. All class D to Mod. Street specs.
- C. GTA's 2000 GTV and Spyder with carbs All class D to Improved Street specs.
 All class E to Mod. Street specs.
- B. GTA jr. 1750 GTV & Spyder with carb 2000 GTV & Spyder with F.I. All class E to Imp St spec All class F to Mod St spec
- E. 2000 Berlina 1750 GTV & Spyder with F.I. 1600 GT,GTV, & Duetto 101-1600 Veloce sprint & Spyder All class F to Imp St spec All class G to Mod St spec

- All 1300 Veloce Cars 1600 Normal Sprint & Spyder 1600 Giulia Supers & TI Supers 1750 Berlina All class G to Imp St spec
- G. all 1300 Normals 1600 Giulia TI(single Carb)
- NOTE; All cars except SCCA pre pared cars must be street legal when closed exaust, DOT tires, and bumpers are instal-led. All "Gutted" cars are to be treated as SCCA cars of the same displacement. Any excessive increase in disphacement thru increasing the bore more then the lmm allowed will cause same car to be moved up to the next higher class.

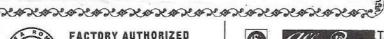
