

TIME TRIAL REPORT

Riverside is an exciting track. Imagine a club with twenty-three drivers and one hundred spectators renting a facility normally hosting hundreds of drivers and almost 100,000 spectators. Yet we can do it thanks to the owners and operators of the track and thanks to our event sponsors. Leonard Greenfeld of Rusnak Alfa-Ww agreed to sponsor this event and he came out to it with his pretty daughter.

We used the Can-Am course this time, which is a 3.2 mile course employing a fiendish turn (8) before dumping you onto a one-mile straightaway. You enter turn 8 at about 90 mph to find that it is a sharply decreasing radius turn. You have to brake and downshift while turning more and more in order to negotiate the final 40 mph kink at the end. You then exit onto the straightaway on which a stock Alfa will do about 110 mph before reaching turn 9.

It was very foggy Saturday morning with visibility about 50 feet. When I reached the pits, I spotted a thick patch of fog at the Start/Finish Line. Being curious I decided to investigate. In the middle I found Nancy Vegher and Sue Bernstein at the registration table, having been lulled to sleep by the resonant snores of Dave Vegher who was slouched in his Berlina. Luckily Sid and Beth Keely arrived with a hugh pot of coffee which was duly administered to the sleeping beauties (and to the beast).


