




### JANUARY MEETING




# TIME TRIAL REPORT

The last Time Trial of 1980 was sponsored by Beach Imports. Beach Imports has been a long time supporter of the events at RIR and we look forward to further close relations with this cutstanding Orange County dealership.



This time trial was different in the respect that a bit of Alfa Romeo history was present in the form of Joe De Loretto's newly acquired T-33 TT. This very car was part of Alfa's successful campaign for the World Manufacturer's Championship in 1975. Joe was present at Autodelta as the car was being refurbished and he over saw the whole operation. The T-33 3-liter, flat 12 engine sounded incredible; it puts out over 500 horsepower.



Joe was allowed to put on a demonstration for all the Alfisti surrounding the track, and the clicking of camera shutters almost overcame the din of the T-33 engine. The image of the newly painted T-33 zipping around the track at one of AROSC's Time Trials will long be remembered.

As soon as the T-33 ended all our Alfa fantasies, the time trial resumed as usual. Practice was fairly uneventful except for a large oil spill that sent a number of cars spinning as well as haulting practice. Practice finally resumed after enough cement dust was applied to the oil.

After the afternoon practices were over the timed runs began in ernest. In Class G John Ireland made it two in a row with a very fast time of 2:00.44. Some people say John was turning 1:58's in practice, if so it would be a new lap



record, but the official timed laps are the only ones that count. Next time John will turn one of those quick ones when it counts. Robert Crowl being a first time novice, drove very well turning a 2:07.02 to take second away from a very determined Bob Braslau who sped to a 2:08.32. These guys should have a great battle next year. Inese Lacey drove consistently, her fastest lap being a 2:12.49 and Lisa Brown another first time novice did nothing silly going 2:29.92.





The consistent great competition of Class F was even hotter at this event. Not to be denied as he was last time out, was this years answer to Jacques Laffite, the flying Frenchman Phil Guiral. Phil, who says he likes to "keepa the hammer downa alla the time-ah", flew to a new Short course record



of 1:55.92. The previous lap record of 1:56.76 was set by Charlie Thieriot in 1976. Phil ends up the year with 3 firsts, 2 lap records, and a second. Second place went to another fierce competitor Dino Crescentini who turned 1:57.25. Andy Steben was also in the hunt with a 1:58.22. A little further back was

the long unseen Henry Manney IV with a 2:00.74 followed by Sergio Perticucci 2:03.47, and Vince Kwan 2:04.17.



The tremendous battle of Class E starring Dan Bernstein, Rich Washington, Rick Alfvin and Pete Stader was again in progress. The only absentee was the last time trial winner Rick Alfvin. Dan, Rick and Rich had each won a Time Trial this year, and we all knew that the fender to fender competition would continue until the final checkered on the final run group. That's exactly how it went too, as Pete Stader got to get an extra lap all by himself because of being held up by another competitor.

Pete didn't play around, he really "screwed-em on tight" and clicked off a 1:54.70. This time made Pete the fourth different competitor to win this class this year. Not only is he the fourth different person to win, but also in the fourth different type of Alfa. The AROSC Time Trial Code really works. Second went to ever fast Dan Bernstein with a 1:55.91, and third went to Rich with a 1:56.53. Raul Perez continued to improve with a 2:03.57.



Class D saw the upset of the day Art Canning drove his good occur. ole reliable yellow Spyder like one possessed, and flew by an astonished but also very fast Alan Ward. Art must have been taking driving lessons from Richard Petty because his line through turn six had 2 wheels in the dirt all the way around, while spectators had their hearts in their throats. His incredible time of 1:51.89 was over a second faster than Alan's best of 1:53.05. Way to drive Art. It should be a real battle between you and Alan next year. Phyllis Gaylard went very respectably with a 1:57.00. Allan Gott went 2 seconds faster than he has ever gone before turning a remarkable 1:57.78. Yeah ALLAN!! Janet Kneisel in her blood red monster Alfetta GT broke the 2 minute barrier with a 1:58.45 and George Vrtiak drove well with a 1:58.69.

In Class B, "The Big Boys" Mike Sperry and Kent Jamison went tooth and nail again. Kent's new slick shod 2000 Spyder finally prevailed by a very narrow margin over the hard driving display of Sperry's. Kent's time was 1:44.69, Mike's was 1:44.89. It's really great to see these two guys compete so closely. Their driving skills have come a long way in just a short time. Steve Fog's newly finished GTA went well and sounded great, turning a respectable 1:51.77.

In Class A, the "Blue Bomb" 1600 TZ of yours truly developed a high speed chassis vibration on the warm up lap, almost spun at turn 2, but continued on for one disappointingly un-fun lap and then decided to find the problem and retired. Much to my delight the car still took Top Time honors with a 1:43.02. Thanks Maw!

The Time Trial program of 1980 is at an end. Year end points are being totaled, and the trophies are being bought. At this time I would like to make all the time trial participants aware of work put out by a few people. 
