

On Saturday morning, January 17, 57 people, AROSC members and invited guests, met and toured through the San Sylmar Tower of Beauty, a unique treasurehouse owned by the Merle Norman Cosmetics firm. Within this impressive building is the personal collection of Mr. and Mrs. J.B. Nethercutt. Mr. Nethercutt is chairman of the board and chief executive officer.


The tour group gathered and was welcomed by curator Byron Matoon, who provided interesting sidelights about the "objects d'art" on display. He explained that the Nethercutt's philosophy was that the collection be "functional fine art", and as such, be in perfect working order...even put to use, on occasion.



The first stop was the Grand Salon, entered through two huge Bronze doors (made locally), cast in Renaisance style, and towering over ten feet high and weighing approximately 1500 pounds. Displayed on the marble floor, and surrounded by marble columns and mirrored walls, were 22 shinning examples of the finest American and European classic cars. The "star" of the collection was a 1934 Duesenberg "twenty grand" however all of the autos were stars in their own right and included a 16 cylinder Cadillac, Pierce-Arrow,





Locomobile, Rudy Valentino's 1923 Voisin (French), "Fatty" Arbuckle's 1923 McFarlan, a racing Bugatti, an MG TC (?!), but alas, no Alfa Romeo. (I understand Mr. Nethercutt's son drives an Alfa). The displayed cars are rotated periodically with nearly 100 restored classics, housed in the nearby shops.

Some of the other features of the Grand Salon are: Bavarian crystal chandeliers - glittering against a hand painted ceiling with 24 carat gold-leafed decorative cast plaster; the Grand Staircase - featuring an 1893 Tiffany "Grandfather" clock with a hand-carved solid Cuban Mahogany case; the Mezzanine - with a superb collection of furniture of the Louis XV era, including the only copy in the Western hemisphere of King Louis' fabulous inlaid wood and gold trimmed desk. Also on the mezzanine, was the fabulous collection of radiator cap ornaments, some made of Lalique crystal.


From the mezzanine, the group moved to the second floor and a fantastic display of mechanized musical instruments...providing beauty as well as real music to the ambience of San Sylmar. They ranged from small and large cylinder and disc music boxes, to reproducing grand pianos, large and lavish orchestrions, and a mag-nificent 1926 Wurlitzer Theatre Pipe Organ, restored with a four-manual corsole and 2500 pipes. Mr. Matoon activated all the instruments for of-the-century music, in turn-of-the century splender!

Of particular interest were the reproducer pianos, which function similarly to a player piano, with an important difference. While both are controlled by a mechanically punched tape (paper roll), the reproducer piano uses a special tape punched by the playing of a renown artist of the time, hence, "reproducer" piano...sounding just like when it was first played!

On occassion, the Nethercutts entertain friends at dinner, with a dining room beautifully decorated with Louis XV style table, chairs, and place settings. The intricate details, the breathtaking magnificence of the setting, is really beyond the scope of this article... marble floors and columns, gold-leafed ceilings, hand-wrought iron balustrades - guilded with gold... all combine to provide an unforgetable environment.

The Alfa group was fortunate in that a witty, charming AROSC member arranged to have the restoration shop as part of the tour. (this is not usually done). It was well organized and clean, as befits the dedication to beauty and function evident throughout the premises.

Naturally, the inspiration engendered by such beauty, provided the impetus for a few of us cognoscentito gather at the El Presidente restaurante nearby, to wolf-down tacos and margaritas! A fitting end to a beautiful day.




